The Restoration Contract Process:

The Restoration contract is an agreement between the student and instructional faculty for classes that are negatively affecting the student's eligibility status.

After the weekly review of the academic status report by the administration, those students who do not meet academic eligibility standards will be called to the school office to talk to the administration and be issued a Restoration contract.

The student will be responsible to meet with the teacher(s) of the class(es) they are deficient in, and complete the contract. The student, teacher, and a parent will need to sign the contract and have it returned to the administration for a final signature approval no later than two school days after the contract is issued.

Contract Level #1

The student may continue to participate in extracurricular activities while fulfilling the requirements of the Restoration contract.

Upon completion of the contract, the student must maintain the eligibility requirements until the end of the semester.

If the contract is not completed as agreed upon, the student will be removed from participation in extracurricular activities until the contract is completed. In addition, the student will form a restoration plan with the coach or advisor of the affected extracurricular activity; this plan is to encourage accountability and discipleship as the student works toward completing the contract. Upon completion of the contract, the student must maintain the eligibility requirements until the end of the semester.

Contract Level #2

The student will not be able to participate in extracurricular activities until the Restoration contract is completed. In addition, the student will form a restoration plan with the coach or advisor of the affected extracurricular activity; this plan is to encourage accountability and discipleship as the student works toward completing the contract.

Upon completion of the contract, the student must maintain the eligibility requirements until the end of the semester.

Contract Level #3

The student will not be able to participate in the affected extracurricular activity for its duration: if a sport, for the remainder of the season; if a leadership position, the remainder of the semester. The administration reserves the right to set a duration time appropriate to the extracurricular activity affected.

Upon completion of the contract, the student must maintain the eligibility requirements until the end of the semester.
